What is Title I?

Crooked River Elementary School is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to the challenging State academic standards to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. All Title I schools must annually jointly develop with parents and family members a written parent and family engagement plan.

School Plan for Shared Student Achievement

What is it? This is a plan that describes how Crooked River Elementary School will provide opportunities to improve family engagement to support student learning. Crooked River Elementary School values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Crooked River Elementary School will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

How is it revised? Crooked River Elementary School invited all parents to attend our annual Stakeholder Input meeting last spring to review and revise this parent and family engagement policy, as well as the school wide plan, our school-parent compact, and the family engagement budget. The plan is posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey online to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year including our annual Stakeholder Input Meeting. All efforts are made to address opportunities for regular meetings and events as requested by parents. The school will submit any parent comments to the district Director of Federal programs, Dr. Denise Cato, if the Title I school wide plan is not satisfactory to parents.

Who is it for? All students and their families are encouraged and invited to fully participate in the opportunities described in this plan. Crooked River Elementary will provide full opportunity for the participation of parents and family members with limited English, parents with disabilities and parents of students with disabilities, parents of migratory children, as well as guardians of children served through the Methodist Children's Home. Crooked River Elementary School will offer childcare and transportation to the extent practicable upon request.

Where is it available? Once adopted, the plan is posted on-line on the school website, in the school resource room, in the front office.

Elementary School Promotion Standards

Students must pass language arts, reading, mathematics, science, and social studies and connections courses as they apply.

- All students in grades 1-2 must have passing final grades of 70% or higher in language arts, and mathematics and "S" for satisfactory in science and social studies.
- All students in grades 3 5 must have passing final grades of 70% or higher in language arts, mathematics, science, and social studies.
- 3rd Grade students must also pass the Reading portion of the Georgia Milestones EOG.
- 5th Grade students must also pass the Reading and Mathematics portion of the Georgia Milesones EOG.

Parent Resource Center

The Parent Resource Center is stocked with a variety of materials and resources to help your child achieve academic success. It is located in the media center. *Open school days from 8:00 – 4:00.*

2023-2024 District Goals

- To increase the percentage of students in grades 3- 12 meeting proficient or higher on the GMAS ELA EOC/EOG from 53% to 56% (ES), from 52% to 55% (MS), and from 59% to 62% (HS).
- To increase the percentage of students in grades 3- 12 meeting proficient or higher on the GMAS Math EOC/EOG from 59% to 62% (ES), from 47% to 50% (MS), from 50% to 53% (HS).
- To increase the percentage of students in grades 3- 12 meeting proficient or higher on the GMAS Science EOC/EOG from 64% to 67% (ES), from 59% to 62% (MS), from 66% to 69% (HS).

2023-2024 School Goals

- To increase the percentage of students in grades 3-5 meeting proficient or higher on the GMAS ELA EOG from 49% to 52%.
 (Increase the reading Lexile level of all learners.)
- To increase the percentage of students in grades 3-5 meeting proficient or higher on the GMAS Math EOG from 51% to 54%. (Increase the mathematical fluency of all learners.)
- To lower the percentage of students missing greater than 10 days from 50%

Each spring a Stakeholder meeting is held to gather input, collect feedback, and review the School-Parent-Compact and Parent & Family Engagement Plan as well as gather input on the Title I funds set aside for parent engagement activites. Input is also gathered on the topics related to building the capacity of staff to collaborate with families for student achievement. An annual meeting is held each fall prior to November 1st to share the Title I documents and plans and the activities for the year. The school's academic status, parental rights to teacher qualifications, and the Federal Complaints Procedure are also shared.
